

Rule Book Change Synopsis 2008 Edition 8.5

Summary:

The 2008 Edition 8.5 of the rule book is provided on the JCNA Website Concours Page, below the *Rule Book Synopsis* heading, for those who do not have the 2007 Edition 8.4, the 2006 Edition 8.3, the 2005 Edition 8.2, the 2004 Edition 8.1 or the 2003 8th Edition and wish to print the entire rule book. **Those holding previous editions and wishing to update their rule book should follow the action headings below.**

The changes to the 2008 8.5 Edition are:

- **Chapter II:** Page 1, **Section 1, Item 6** has changed by allowing trailering in all Divisions and adding sentences mandating that the Chief Judge confirm that Entries are driven to their assigned parking positions on the Concours Field. Page 3, **Section 2, Item B**, has changed to reflect the split in Champion Class 19 into 19A and 19B, and adding Class C20. Page 6, **Item B** has changed to add Class D12 for the new XF Model.
- **Chapter V:** Page 8, **Item 11 – License Plate Frame and Plate Clear Covers** may not have been updated to reflect the changes implemented at the 2007 AGM on some versions of Edition 8.4. It has now been updated.
- **Chapter VI:** Page 7, **Items 34 and 36** have changed and the notes re-lettered. Page 8, **Note a - Antennas** has been changed and the notes have been re-lettered. Page 9, **Note 1 – Side Protective Moldings** and **Note m – Sunroofs** have been rewritten. Page 11, **Item 10 – Carpet Section** has been changed and **Item 13 - Dash Plagues** has been added, requiring renumbering through Page 12. Page 16, **Item 14 – Cam Covers** and **Item 28 – Distributor** have been added, requiring renumbering through page 17.
- **Appendixes A, C, & D** have been updated.

Rule Book Change Synopsis 2007 Edition 8.4

The changes to the 2007 8.4 Edition were:

- **Chapter II:** Page 3 has been changed to reflect the split in Champion Division Class 16 to 16a & 16b. Page 6 has been changed to reflect the split in Driven Division Class 9 to 9a and 9b.
- **Chapter III:** Pages 6, 7, & 8 have been revised to clarify confusing language held over from previous editions and delete the “whole Jaguar judging” method of judging. Page 11, J.1.c. has an editor’s change to conform to previous AGM changes in Chapter I. On page 13, J.14 has been changed to reflect the previous change in J.13 and language cautioning judges on unnecessary discussion with the Entrant has been added. On page 14, language on conferring with team members when assigning large deductions has been added.
- **Chapter V:** Pages 1 and 2 have been changed to add language regarding decals, labels, or permits. Page 5 has been revised to add language regarding body stripes (coach lines), but **will not** be implemented until 2008; pages 6 – 7 have been reordered as a result of the change on page 5. Page 8 contains language clarifying the non-authenticity of redline tires applies to Champion Division only and adds words to C.11 License Plate Frames and Plate Clear Covers. Pages inclusive of page 9 have been renumbered to the end of the chapter; page 11 clarifies electronic device installation in Driven Division.
- **Chapter VI:** Page 9 has been changed to add Note j. Body Stripes (Coach Lines) but **will not** be implemented until 2008; subsequent notes through page 10 have been re-lettered. On page 16, line #26 has been changed to match the deduction listed on page 5. On Page 18, Note e. has been revised to reflect new information regarding Hose Clamps, but **will not** be implemented until 2008.
- **Appendix A** has been updated to reflect new models.
- **Appendix C** has been updated to reflect the acceptance of 2-new Judges’ Guides.
- **Appendix D** has been updated to reflect the class changes here before mentioned in Chapter II.

Rule Book Change Synopsis 2006 Edition 8.3

The changes to the 2006 8.3 Edition were:

- **Chapter I:** The Chapter has been completely rewritten.
- **Chapter II:** Page 1 Section 1, A.5.a. - "S2" has been deleted from the paragraph and a new A.5.b has been added that required the relettering of A.5.c.
- **Chapter V:** The Chapter has been completely rewritten.
- **Chapter VI:** This Chapter goes into effect for the first time this year, minor changes and additions were made from the previous posted edition approved at the 2005 AGM for implementation in 2006.
- **Score Sheet Changes:** Minor wording changes were made and the terminology was made more consistent

Rule Book Change Synopsis 2005 Edition 8.2

The changes to the 2005 8.2 Edition were:

- **Chapter II:** The XJS Classes in both Champion and Driven Divisions have been split and a luggage rack authenticity exception was added to Driven Division.
- **Chapter III:** A new Operation Verification (formerly Mechanical) Section has been added and changes made regarding Judge's Reporting.
- **Score Sheet changes:**
 - Operation Verification (formerly Mechanical) has been placed on a separate page.
 - The Boot component has been moved to the Interior Sheet.
 - Tabular spaces have been added in which Judges must indicate the locations and describe major Condition and Cleanliness deductions.

Rule Book Change Synopsis 2004 Edition 8.1

The major changes in the 2004 8.1 Edition were the complete rewrite of Chapters II and IV. In particular, some Champion and Driven classes were changed, Driven classes were allowed authenticity exceptions and a new Special Division was added. The remaining chapters were edited to reflect the Chapter II and IV changes. A small change in Chapter III modified the recommended use of JCNA Judging Guides.

Appendix B, Tires and Wheels, was reformatted and updated, eliminating the "not for use in judging" caveat. A new Appendix C listed Official Publications for Documenting Authenticity.

Chapters I, III, V, and VI need not be replaced by holders of Edition 8 if they are well aware of the changes in Chapters II and IV and the minor change in Chapter III.
