

Jaguar Club of Greater Cincinnati's 2017 Concours d'Elegance will be held on Saturday, July 29, at the Council Bluff Shelter at Sharon Woods Park in Sharonville, Ohio. The Concours is a J.C.N.A. sanctioned event. Sharon Woods Park is located on the north side of the Cincinnati area and convenient to I-275, I-75, and I-71. The Park includes a heritage village that is very much worth a visit during show day (separate entry fee required).

Show participants will park on grass for the day. Box lunches may be ordered on the attached registration form, with beverages available throughout the day. The awards presentation will take place at the shelter about 4 p.m., thus facilitating the opportunity for a reasonable departure time for those who have long journeys.

For those wishing to meet after the awards presentation, we will gather at a nearby pub for a nohost happy hour and dinner.

A pre-Concours, Friday evening reception, hosted by the Club, will be held at Jaguar Land Rover Cincinnati's impressive showroom and service facility, on Blue Ash Road in Blue Ash, Ohio (northwest Cincinnati). Of particular interest is the dealership's heritage collection of Jaguars on display in the new building.





This reception is always fun and is a good way to meet others before the concours. Gourmet hors d'oeuvres and select beverages will be served. We welcome all who can attend.

This event does not have a host hotel. Dozens of hotels are located in the northern Cincinnati area. Because of high demand for rooms throughout the summer, most are sold out or have only a few rooms available on show weekend. We recommended that you search online for hotels near Sharonville, and make reservations as soon as possible.

Directions to Concours: Sharon Woods Park, 11450 Lebanon Road, Sharonville, Ohio 45241.

Take I-75 to I-275 East or I-71 to I-275 West (I-275 in Ohio, north of Cincinnati, not in Kentucky). Exit I-275 at U.S. 42 toward Sharonville/Mason (Exit 46). Turn right from I-275 East or left from I-275 West onto U.S. 42 South/Lebanon Road. Follow U.S. 42/Lebanon Road for 0.9 miles. Turn left into Sharon Woods Park entrance. Inform gate security officer you are attending Jaguar Club event at Council Bluff Shelter for free entry. Participants bringing trailers must pre-register, and will be provided parking instructions before the show.

Concours Regulations

- 1. Owner, or member of immediate family, is asked to be with the car at time of judging, extending courteous cooperation to all judges.
- 2. Bonnet and boot must be closed at commencement of judging.
- 3. Roadster's and Drop Head Coupe's removable side screens should be displayed alongside the car.
- 4. All other cars should have doors and side windows closed.
- 5. Proof of originality is the responsibility of the owner.
- 6. All cars are judged in place, each class as a unit.
- 7. The only vehicle preparation allowed after 12:00 p.m. is dusting.
- 8. Scoring questions should be addressed to the Chief Judge, prior to class judging. Judges' decisions are final.
- 9. All vehicles to be judged must be driven to the judging area.
- 10. Tool kits, jack rolls and owners' manuals should be displayed outside judged vehicle in Champion classes.
- 11. Class trophies will not be mailed. Please make prior arrangements if you cannot be at the Awards Presentation.
- 12. Each entrant will receive by mail, shortly after the Concours, his or her judging forms. Copies of all scores will be maintained.
- 13. JCNA will receive copies of scores for all cars entered in the JCNA classes in Jaguar Club of Greater Cincinnati Concours for selection of annual awards for North America and regional competitions.
- 14. Entrants will be assigned to classes in accordance with Official JCNA Concours d'Elegance Rule Book.
