FINAL REPORT OF THE JCNA NOMINATING COMMITTEE

Here are the FINAL results of the election of the JCNA Regional Directors for the 2014 -to- 2016 JCNA Board of Directors - with a TOTAL of 505 votes cast- (including a TOTAL of 26 (5%) invalid ballots received - as judged in accordance to JCNA By-laws.)

This represents appx. 11% of the membership of JCNA casting their Ballot for their Regional Director. (Which is not TOO bad -considering that each of the Candidates was running un-opposed.) I have also noted the appox. percentage of the membership voting in each Regional District. (Figures are based on the Membership numbers of March of 2012 & 2013.)

For your possible interest- I have also compared the # of votes cast in the current election where all Candidates ran un-opposed - with an indication of % increase (\geq) OR decrease (\leq) as vrs last year's (2013 - 2015) R/D election. You will note that only in the S-W Region was there a significant decrease ($<$) in the number of votes cast - believed due to the presence of opposing candidates in the S-W Region in the previous Election. In all other Regions (excepting the N-C Region) there was an Increase ($>$) in votes cast.
