#### 2. Slalom Equipment Rebate

JCNA will reimburse for Slalom timing equipment \$250 or 50% of the cost. The 2 Slalom event prerequisite will be dropped.

#### 3. Snowbirds dual Club membership

Some snowbirds earn two regional awards and vote twice.

They must use their one root JCNA number.
